4	You will do the cleaning and vacuum the pool daily including skimming of any floating debris on the pool Surface.
5	You will do the brushing of pool walls and floors daily.
6	You will carry out the check pressure reading of filter and back wash as and when necessary.
7	You will supply necessary consumables chemicals for cleaning like trichloroacetic acid, sodium hydrochloride, soda ash, bleaching powder, etc.
8	The necessary provision of life guard cum attendant will be made by you on daily basis on eight hours per day. Duty hours will be from 6.00am to 10.00am in morning session and 4.00pm to 8.00pm in the afternoon session. Life guard cum attendant should possess the requisite qualification and license as per PMC Rules.
9	Cleaning work of swimming pool should be carried out between 10.00am to 4.00pm only and cleaner should look after filtration work properly.
10	The payment of AMC will be made on monthly basis on 10 th of every month after the receipt of satisfactory report from the Swimming pool Incharge. The payment of Life Guard will be made only for the actual present days per month.
11	Pool sweeper machine of FTII will be made available for daily maintenance work. Swimming pool may be kept close for cleaning purpose as a routine maintenance with prior intimation to FTII.
12	The FTII office may impose suitable penalty in case of defaults and also reserves the right to renew or to terminate contract without any prior notice to you at any time without assigning any reason.
