(I) Forwarding letter on the Official letter head of the firm/agency/Vendor. (ii) Supporting documents of previous experience in the related field. (iii) Supporting technical literature/brochure on the brand items for which the rate are Quoted.
2	Loss or delay in postal/courier transit will not be considered as valid reason for non-receipt of the tender in time.
3	Quotation should indicate the ' rate per unit item ' on FREE DELIVERY AT SITE basis and shall be INCLUSIVE OF ALL APPLICABLE TAXES as well as INSTALLATION COST and COMMISSIONING at the User Department.
4	Tenderer should also confirm the stipulated warranty period mentioned with the specification of each items at the columns specified in the Price bid proforma.

Acoustic work to be done at FTII, Pune Acting department studio one

- **Studio size - 37 ft. x 17 ft. x 09 ft. height.**
- **Work to be done for the area is - 1500 sq. ft area including Ceiling.**

A) Ceiling

9 mm, 8 x 4 compressed synthetic Polyfiber which gives a minimum 0.5 noise reduction coefficient (NRC) against ceiling (Make - sound out).

Area 650 sq. ft.

B) Wall (Lower Reach / Skirting)

Salon Slots L 16-2 wall panels with synthetic wool (Polyfiber) of 50 mm, 500 gsm along with wooden framing giving noise reduction coefficient (NRC) value up to 0.75. The wooden panel slots shall be density of 800 kg / m³.

C) Wall (Upper Reach)

Wall Panelling to be made in Fabric finish above 4ft height from flooring. Fabric finish panel is pre finished, directly to be installed on wall with the help of welcrow material. 02 ft. x 02 ft. 60 nos. pre - finished panel shall be of 50 mm thick giving performance of 0.94 noise reduction coefficient (NRC) against wall (Approved make - sound out) (as per design).

D) Floors

Floor shall not have a reflective surface. The Floor shall have absorptive surface can either be a carpet finish or a heatlon carpet. It shall have minimal absorptive properties and shall not reflect sound. Preferally any type of carpet or heatlon surface.

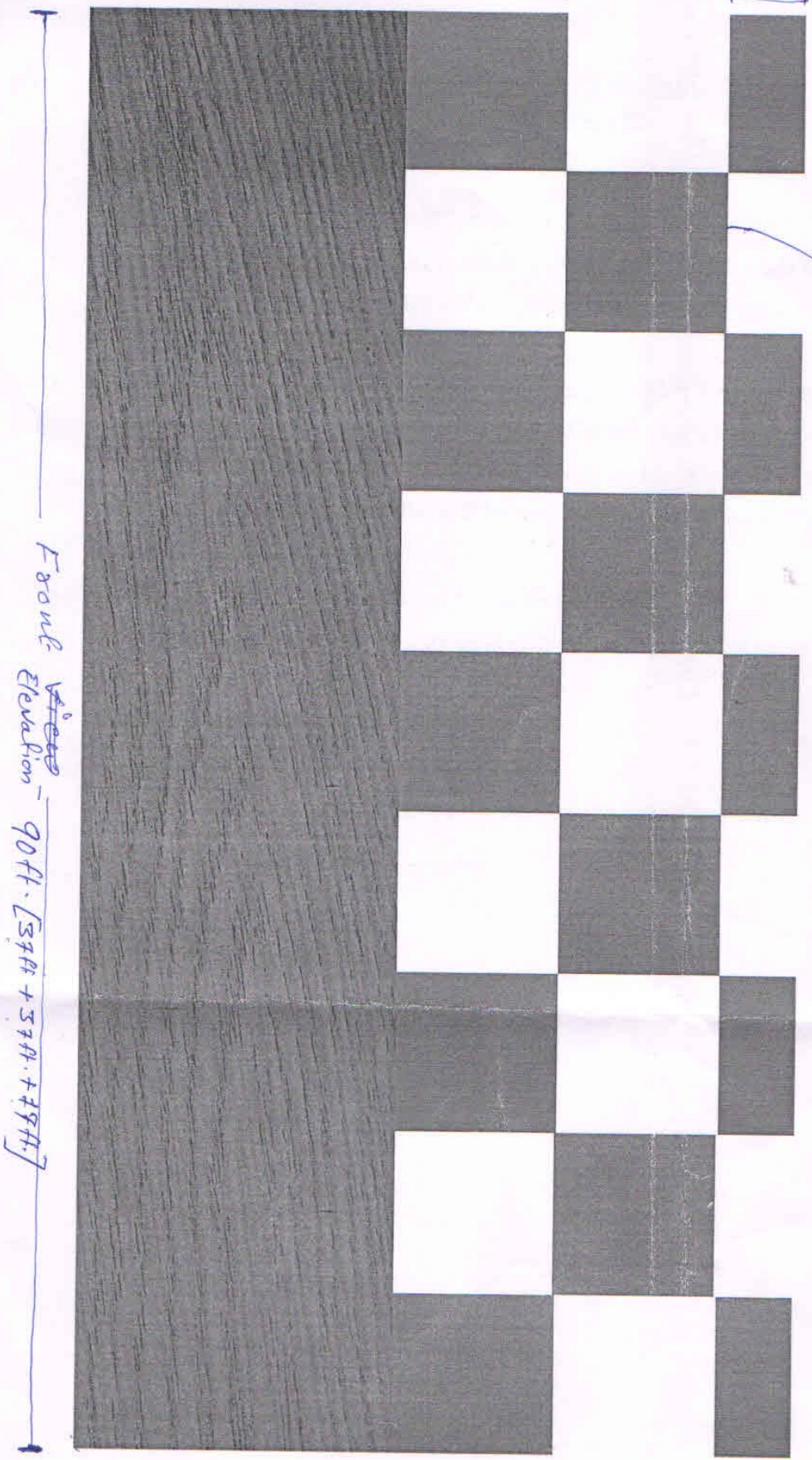
E) Painting of all the walls with white oil bound distemper paint.
