Comprehensive Annual Maintenance Contract of CCTV Camera Systems, in the Film and Television Institute of India , Pune, for the period of one year which can be extended upto three years with incase services found satisfactory of earlier period.

Terms & Conditions

1. Online e-tenders are invited by the FTII under Two bid system through Central Public Procurement Portal, for Comprehensive Annual Maintenance Contract of CCTV Camera Systems, in the Film and Television Institute of India , Pune, for the period of one year as per the list enclosed at Annexute - I.
2. The tender documents can be downloaded from the websites of <http://eprocure.gov.in/eprocure/app> as well as www.ftiindia.com from dt. **14.08.2017** to **11.09.2017**(upto 3.00 pm).
3. The interested bidders may submit the tenders online at <http://eprocure.gov.in/eprocure/app> in Two bid system in the prescribed proforma. Tenders are to be submitted online only through e-procurement portal <http://eprocure.gov.in/eprocure/app>. All the documents in support of the eligibility criteria etc are to be scanned and uploaded along with the Tender document. Tenders sent by any other mode or incomplete tenders will not be accepted. No tender documents will be accepted after the expiry of stipulated date and time for the purpose under any circumstances whatsoever.
4. The bids will be opened online by Tender Opening Committee in the FTII on dated **12.09.2017** at time 3.30 p.m., FTII, Pune. Bidding parties or their authorized representatives can also be present at the time of opening of bids. Only one representative on behalf of a tenderer shall be allowed to be present at the occasion. The Tender Evaluation Committee (TEC) , after evaluation of the bids, will give Tender Evaluation Report duly signed by the members of the Committee.
5. The original Tender Fee and Earnest Money Deposit by means of a Demand Draft/ Banker's Cheque for Rs. 1,500/- (Rs. One thousand five hundred) and Rs. 6,000/- (Rs. Six Thousand) respectively in the name of Accounts Officer FTII, Pune, physically must be dropped only in FTII, Pune between 9.30 to 3.00 p.m. on dt. **11.09.2017**. In case original Tender Fee and EMD is not submitted during the above date and time , the bids will be rejected summarily. The bidder shall be disqualified and such bid will not be considered. However scanned copy of Bank Draft must be uploaded electronically on Central Public Procurement Portal. Tender Fee is non-refundable. EMD of unsuccessful bidder will be

returned to them after the award of the contract. No interest is payable on this EMD. No bidder is allowed to withdraw application after submission of bid, if a bidder wants to withdraw, either before or after award of contract their EMD will be forfeited.

6. Successful bidder will be required to furnish Security of Rs.15000/- (Rs. Fifteen Thousand) in the form of Bank Guarantee Receipt/Fixed Deposit Receipt from any Nationalised / Scheduled Bank. These must be drawn in favour of Accounts Officer, FTII, Pune . Performance security would be refundable within one month of successful completion of the contract period, subject to fulfillment of terms & conditions of AMC and any deductions that may be decided by competent authority. EMD of successful bidder will be returned to them after the award of the contract and completion of due formalities. No interest is payable on this deposit.

7. The payment towards Annual Maintenance Contract shall be made in four installments each at the end of three months/ each quarter on presentations of bills and on production of satisfactory reports from the concerned users.

8. Each page of this tender notice & documents including General Terms and conditions should be signed by the tenderer and rubber stamped in token of having been accepted the same in letter and spirit.

9. The Competent Authority in the FTII, Pune, reserves the right to cancel the tender at any time or amend/withdraw any of the terms and conditions contained in the Tender Document, without assigning any reason, there for.

10. The company/ firm must have similar contracts in at least two Govt. Offices / PSU / Autonomous Bodies / Private Sectors

11. The company/firm must have an experience of 3 years or more in this field.

12. The company/firm should submit its profile and bid on their letter head bearing full address, TIN ,PAN, Service Tax Number, telephone number, mobile number indication past experience, technical capability , details of Service Technician (S), financial position, copies of existing contracts and contracts during last 3 years in Govt. Offices / PSU / Autonomous Bodies / Private Sectors along with documentary proof.

13. The firm should have not been blacklisted by any Govt. Department and no legal suit/ criminal case pending against it. Its owner or proprietor or any partner or having been earlier convicted for violation of any law in force shall not be eligible. An undertaking to this effect duly signed by concerned person should be submitted along with tender documents. This statement, if found to be incorrect in any manner or part there of, at any stage including after award of contract, shall result in for forfeit of EMD or Security Deposit and the contract will also be cancelled immediately.
14. Photo copy of Valid GST / PAN Card / Documents relating to the financial position i.e. balance sheet, profit and loss account of last three years and IT returns should be submitted with Tender Document.
15. The number of Cameras with DVR mentioned in Annexure I may increase or decrease during the period of contract.
16. The initial upgradation / maintenance of the Cameras with DVR will have to be completed within 15 days from the date of commencement of contract and a report should be submitted to the FTII.
17. During the period of contract, the Company will be responsible for proper and consistent functioning of all Cameras with DVR being used by this Institute.
18. The Agency will depute required number of qualified Engineers for attending complaints. The details of Engineers are required to be submitted to FTII, Pune on the letter head of the company along with copy of any identity Card issued to them. The Engineers should have mobile phones and phone numbers should be communicated to the HOD concerned and Tender Inviting Authority for immediate contact. They may also be called on Holidays or required to work after working hours for urgent maintenance to work after working hours for urgent repairs etc. If it is considered necessary.
19. The Engineers deputed by the Company will be required to submit TASK REPORT every day or periodically as decided by this Office.
20. The Company has to use all genuine products/ material of specifications.
21. The Engineers /staff deputed by the Company will not attend to any job directly unless directed by Authorized person of this office.

22. In case any machine goes out of order, the complaint should be attended within 48 hours and repair should be carried out by the Company in the premises of this FTII, Pune. Only such work which cannot be executed in the premises of this FTII, Pune. Will be allowed to be done in the Lab of Company with prior permission of this FTII, Pune for which no extra charges will be payable. In any circumstances the machine should be put in order within same day, failing which a penalty can be imposed with prior approval of Competent Authority.
23. If the FTII, Pune feels that any of the machines, under the contract was not properly maintained/ serviced by the Company or does not function for reasonable period after repair, a reasonable deduction from the bills will be final and binding on the Company.
24. This PERFORMANCE SECURITY is liable to be forfeited, if the services of the company are found to be unsatisfactory in any respect and / or if any or the conditions of tcontract is contravened / breached. And/ or towards any damage is caused to Govt. Property due to the negligence or otherwise of the firm or its employees. This FTII, Pune will be at liberty to entrust the same to any other firm/company at the risk and expense of the defaulting company/firm. The decision of this FTII in the regard shall be final.
25. In all matters of dispute relating to this contract, the decision of this Institute will be final and binding upon the Company/firm.
26. This office reserves the right to reject or to accept any tenders, in whole or in part, without assigning any reason therefore. It also reserves the right to reject the tender without assigning any reason thereof or to renew the contract for such period as it may deem necessary taking into account the services rendered during the contract period.
27. While submitting the tender documents, the bidder will be deemed to have read, understood and accepted all the terms and conditions stated in this document and no change. Whatsoever desired, will be entertained by this FTII, Pune.
28. The period of contract may be extended for a further period of three years on same rates and Terms and conditions subject to satisfactory performance rendered by the firm during the current year.
29. The Vendor will provide the invoice/ bill of all the items replaced and the rates charged for the spares should be reasonable and at par with the market price.

30. BOQ should indicate the 'rate per unit item' on FREE DELIVERY AT SITE basis and shall be INCLUSIVE OF ALL APPLICABLE TAXES, as well as INSTALLATION COST and COMMISSIONING at the User Department.

31. BOQ / Price Bid should be submitted only through Central Public Procurement Portal.
